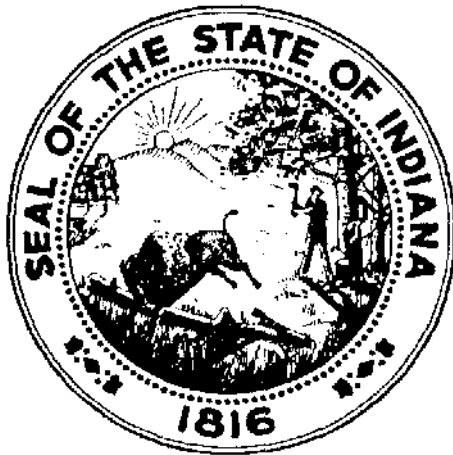

ARTICLE I
NAME

ARTICLE II


ARTICLE VII
