On September 19, 2012 at 1:00 p.m., the Metropolitan Development Commission of Marion County, Indiana ("MDC"), governing body of the Department of Metropolitan Development ("DMD"), will open and consider all proposals received prior to the 10:00 a.m. (E.S.T.) deadline. The MDC will then request the DMD to conduct an in depth review of all proposals received and make recommendations to the MDC.

The proposal shall be submitted on the forms provided, accompanied by any additional material the bidder determines as helpful in illustrating its development plans, in a **sealed envelope or parcel.** The proposal shall be submitted as one original and five (5) complete copies.

- 2. The bidder's plans and ability to improve the real property with reasonable promptness.
- 3. Whether the real property when improved will be sold or rented.

- 4. The Bidder's proposed sale or rental price.
- 5. If Bidder is a trust, as defined in IC 30-4-1-1(a), the proposal submitted must identify each beneficiary of the trust and each settle or empowered to revoke or modify the trust.
- 6. Any factors that will assure the MDC that the sale or lease, if made, will further the execution of the redevelopment plan and best serve the interest of the community from the standpoint of both human and economic welfare.
