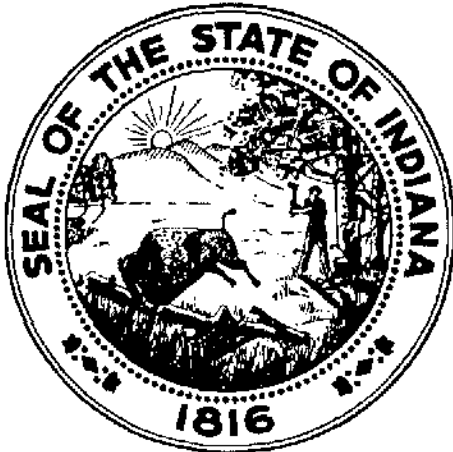

ARTICLES OF INCORPORATION

The undersigned incorporator or incorporators, desiring to form a corporation (*hereinafter referred to as the "Corporation"*) pursuant to the provisions of the Indiana Nonprofit Corporation Act of 1991 (*hereinafter referred to as the "Act"*), execute the following Articles of Incorporation.

ARTICLE I - Name and Principal Office

ARTICLE II - Purpose (optional)

The purposes for which the Corporation is formed are:

This corporation is organized exclusively for public purposes with the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, for such purposes, the making of distribution to organization that have the same public purpose. To this end, the corporation shall:

- (A) To promote HIV/AIDS awareness and education to all residents throughout the State of Indiana and beyond.
- (B) To provide comprehensive services to all individuals infected and affected by HIV/AIDS.
- (C) To promote the value of healthy marriages and families and the skills needed to increase marital stability throughout the State of Indiana.
- (D) To bring together faith-based and community-based organizations, public and private organizations, foundations and citizens of the state to work on efforts in decreasing high risk behavior that leads to HIV/AIDS infection through education of the following: youth, single men, single women, heterosexual married couples, homosexual married couples, homosexual partners, engaged couples or individuals.
- (E) To support the members of the coalition in their efforts to provide activities that will support and preserve the minority population of the State of Indiana and decreasing the number of sexual transmitted diseases including HIV/AIDS.
- (F) To carry out the foregoing purposes in concert and cooperation with other agencies, organizations and/or groups when deemed appropriate.

ARTICLE III - Type of Corporation (check only one)


